
MINUTES OF THE FULL COUNCIL MEETING HELD on the 14th of January 2026 HILLSIDE MEETING ROOM, LILLESHALL, 6:30PM

133/25 Apologies and declarations of Interest

Apologies received from Cllr Challenor (Indisposed), Cllr Eade (Indisposed).

134/25 Public Session

2 members of the public were in attendance. A resident informed members that he had recently spoken to Sgt Edwards of West Mercia Police, regarding the setting up of a Community Speed Watch Scheme in the village. Members agreed to assist in the recruitment of local volunteers by placing an article in the Spring edition of the Parish Newsletter.

A resident representing Friends of Lilleshall Hill Group updated members that a recent meeting held with T&WC Officers had been very useful in advising the group, particularly on how to become an independent community group.

135/25 Minutes of the last Council meeting held 9th of December 2025

The minutes of the last meeting held on the 9th of December 2025 had been previously circulated and were **RESOLVED** to be accepted as a true record.

136/25 Matters arising, for information, from the minutes

Friends of Lilleshall Hill: Details of the historical arrangement with the parish council had been previously circulated to all members. Following a discussion, it was agreed that the parish clerk would arrange a meeting with the Chairman and a representative of FOLH, to assist them with the initial administration that will enable them to become a fully constituted and independent community group.

137/25 Correspondence

138/25 Reports from West Mercia Police

The Chairman read out a written report received from the local PCSO. The following priorities were agreed for the next quarter:

- Speeding vehicles through the village.
- Speeding vehicles along Honnington Grange Road.
- Inconsiderate parking at the local School.

139/25 Reports from Parish Councillors and Ward Member present

140/25 Clerks Report

The Clerk provided members with a brief insight into local issues parish staff have reported and dealt with recently and provided members with the following information:

- Liaising with The Red House regarding support for a local walking group.
- 2 x replacement Defibrillator units need replacing; the clerk will be applying to a Charity for funding.

141/25 T&WC Local Plan Review

Cllr Hoof reassured members that all of the questions raised by members in the consultation on the planned developments in the parish are covered by the appointed Inspector. The meetings are due to be held in February.

142/25 Road Safety Scheme

A copy of the recent data from the Speed Indicator Devices was shared with members. Members concluded the Speed Indicator Devices act as a deterrent in the areas of the village, but recognised this is only applicable in which they are located. However, whilst most drivers were responsible and keep to the speed limit there remains a minority that continue to speed. The Clerk agreed to share the data with the local resident who is trying to establish a community speed watch scheme and Sgt Edwards of West Mercia Police to request a higher police presence.

Summer Day Trip 2026: The Clerk shared a 'snapshot' of a consultation conducted with residents to gather their views on ideas for this year's trip, the majority would like a return trip to Llandudno. The Clerk agree to discuss the matter with Cllr Eade regarding assistance with funding.
